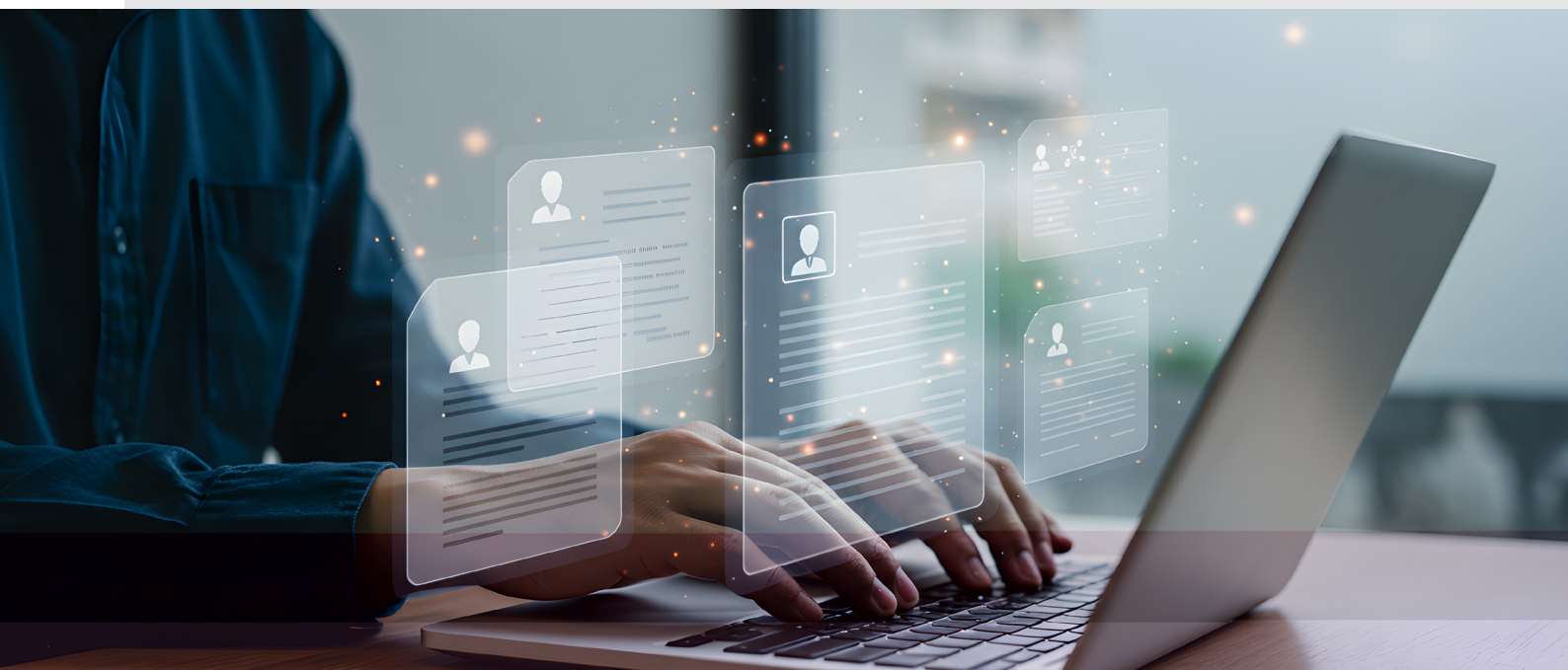
PRIVACY NOTICES
