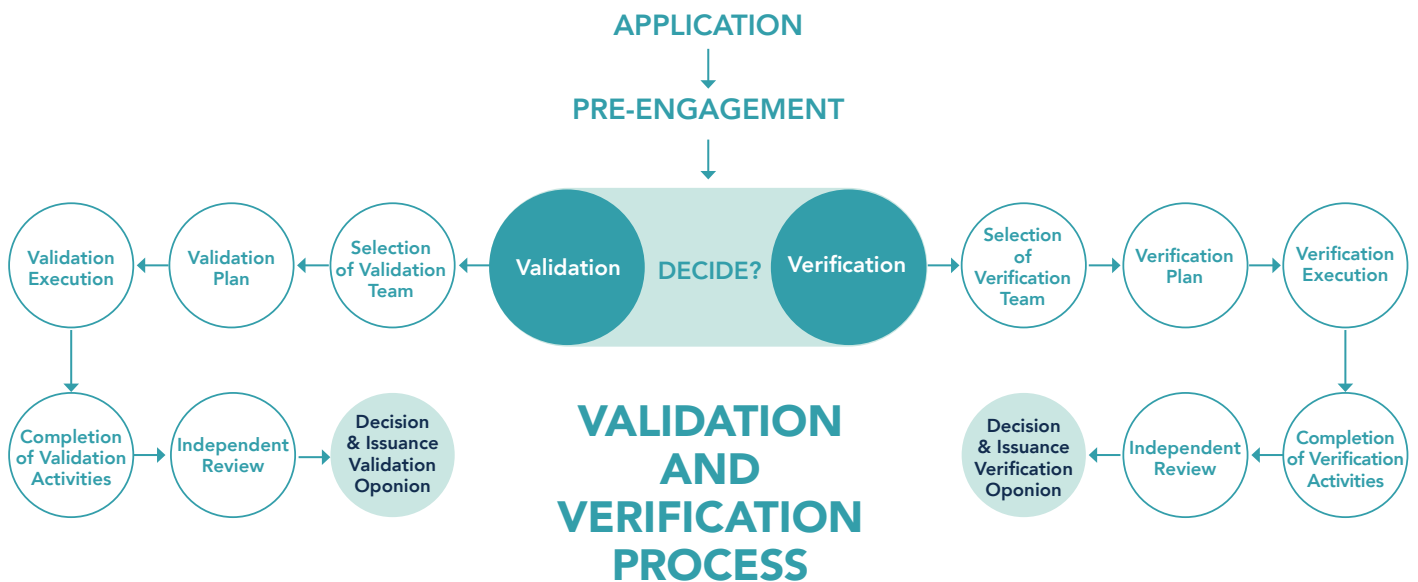


Who is Eligible to Apply for ISO 14064-1?
